**Money back Guarantee:**

Better Homes and the Manufacturer warrants that this product will perform to manufacturers specifications. Should the Better Homes Gutter Defender System not perform as stated per manufacturers specifications, the manufacturer shall have a reasonable opportunity (120 days) to inspect, repair, or replace the system to ensure said performance. If the system does not perform to the specifications designed by the manufacturer the Purchaser will receive a full refund of the monies paid by the Manufacturer of the Better Homes Gutter Defender System. Homeowner must provide a written Notice Within the 120 days allotted.

**Lifetime Free Flowing Warranty:**

Better Homes will warranty to the purchaser of the Better Homes Gutter Defender System to keep the act of free flowing defined as the movement, or the act of flowing, rinsing, or circulating of rainwater. Better Homes Gutter Defender System is

engineered to transfer all but inconsequential droplets of run off water in the gutter when properly installed and maintained. It is the responsibility of Better Homes to assure that the Better Homes Gutter Defender System is performing as designed and has been properly attached to your home without damaging the integrity of the structure. Better Homes Gutter Defender System may be installed over or under shingles according to Factory specifications. As long as the installer is comfortable with the integrity of the structure, Better Homes is not responsible for any gutter system that is not installed by Better Homes.

**Lifetime tree and limb warranty:**

The Better Homes Gutter Defender System is designed to withstand the heaviest snows, ice or debris load of any product available today. The product will be fastened through the fascia and not the roof. The Better Homes Gutter Defender System is also designed to take the impact from falling trees or limbs. If any of the Better Homes Gutter Defender panels, after being properly installed should ever bend or dent as a result of falling trees or limbs, Better Homes will replace any damaged product including all materials and labor.

**Lifetime wind and blow off warranty:**

The Better Homes Gutter Defender System is designed to be installed through the fascia and not the roof actually strengthening the existing or new gutter system. Better Homes

warrants that if the Gutter Defender panels come loose or are caused to be removed completely by winds from 0 – 100 mph, Better Homes will replace the damaged panels including all materials and labor.

**Lifetime Fade Warranty:**

Better Homes Gutter Defender System panels are coated with a Kynar Finish. This finish is one of the strongest and longest lasting coatings on the market today. If the Kynar Finish should ever fade more than 5.0 Hunter Delta Units, Better Homes will provide materials and labor to replace the faded panels for as long as the original owner owns the home.

This Warranty is for the original purchaser for as long as they own there home. The original purchaser may transfer this Warranty in it's entirety one time to the next owner upon resale of the property. The new owners of the property must contact Better Homes within 90 days via Certified mail of closing in writing for the transfer to be valid.
